Purpose:

This course introduces students to the policy process in Canadian local governments. Basic models of policy analysis and the policy process are examined and then applied to the local government setting. The focus is Canadian and municipal, but special purpose bodies and other systems of local government (especially American) are also analyzed.

Readings and Materials:

The readings are a collection of scholarly papers and book chapters that will be distributed electronically to students. Suitable local policy documents may also be distributed from time to time.

Assignments:

The major assignment is a research paper of about 3000 words on a topic related to any of those covered during the course. The paper is worth **50 percent** of the final course grade and is due, in class, on April 6th. Overdue submissions will be penalized one percent of the final course grade for each day that the paper is late. Students will also give a short, 15 minute presentation of their papers during one of the three final seminars. The order of the presentations over those three classes will be set in early March. The presentation is worth **10 percent** of the final course grade.

The secondary assignment is a critical analysis of a local government policy. Guidelines for this assignment will be distributed at the end of January. The analysis should be about 1200 words and is worth **20 percent** of the final course. It is due, in class, on March 10th.

Seminar participation is worth **20 percent** of the final course grade. This will be based on overall contributions to seminar discussion and participation in any group activities that occur during the term.
